DHCS Launches Technical Assistance Marketplace to Support New Medi-Cal Providers

This is an advisory notification to Molina Healthcare of California (MHC) network providers.

The Department of Health Care Services (DHCS) launched the Providing Access and Transforming Health (PATH) Technical Assistance (TA) Marketplace, a one-stop-shop website where providers, community-based organizations, Medi-Cal Tribal and Designees of Indian Health Programs, counties, and other eligible TA recipients can access resources from curated and approved vendors. These resources will help partners further our shared vision of California Advancing and Innovating Medi-Cal (CalAIM), a long-term commitment to innovate and improve Medi-Cal.

As part of DHCS' work to transform Medi-Cal into a more equitable, coordinated, and person-centered health system, the Department is creating new opportunities to access TA resources.

The TA Marketplace allows entities to browse "hands-on" or "off-the-shelf" TA services from an initial offering of 47 unique vendors across seven TA domains. Services offered through the TA Marketplace are provided at no cost to the TA recipient.

"Hands-on" custom TA services allow eligible entities to work closely with experienced vendors to design and implement systems, training, and recruitment processes uniquely suited to their priorities and needs. TA goals, deliverables, and timeframes are all developed "from scratch" and are specific to the individual entity and project. "Off-the-shelf" TA projects have clear, pre-established goals and defined timeframes for easy consideration. Eligible entities can select from a wide range of "off-the-shelf" offerings that are packaged for convenient, efficient delivery and ready to go with minimal planning.

DHCS invites eligible TA recipients to browse the TA Marketplace today and learn how these services can strengthen their capacity to implement Enhanced Care Management and Community Supports. Vendors offer services across the following domains, with the potential for more to be added over time:

- Building knowledge on data capacity.
- Community Supports to strengthen services that address social drivers of health.
- Navigation help with CalAIM and the Medi-Cal managed care delivery system.
- Strengthening care for Enhanced Care Management's Populations of Focus.
- Promoting health equity.

- Supporting cross-sector partnerships, including between managed care plans and counties.
- Recruiting and retaining a well-prepared, high-performing workforce.

To shop TA Marketplace services from vendors beginning on **February 27, 2023**, eligible entities must:

- Submit a recipient registration form on the PATH website: <https://www.ca-path.com/ta-marketplace>. Registrants are asked to provide evidence of a contract(s) with MHC or intent to contract with MHC to provide Enhanced Care Management and/or Community Supports, or approval from DHCS to register as a TA recipient.
