Electronic Visit Verification Onboarding & Self- Registration Live Demonstration Webinar

This is an advisory notification to Molina Healthcare of California (MHC) network providers.

The Department of Health Care Services (DHCS) Electronic Visit Verification (EVV) Team will be hosting a home health care service (HHCS) and individual nurse provider (INP) Onboarding and Self-Registration Live Demonstration Webinar. DHCS is inviting all HHCS providers, INPs, and Jurisdictional Entities (JE) to attend this informational webinar to gain knowledge around EVV requirements for the upcoming HHCS implementation.

During this WebEx event, DHCS will be offering a live demonstration on the California Electronic Visit Verification (CalEVV) Self-Registration Portal and outline required activities related to CalEVV and Alternate EVV. The webinar will share vital information with Medi-Cal providers who are required to comply with EVV requirements as federally mandated. HHCS providers and INPs may now begin Self- registering in CalEVV system and will have until January 1, 2023, to come into compliance.

Background

Federal law mandates that states implement EVV for all Medicaid-funded PCS and HHCS that require an in-home visit by a provider. EVV is a telephone and computer-based solution that electronically verifies in-home service visits occur. California is implementing EVV in two phases. EVV Phase I is for In-Home Supportive Services and HCBA waiver PCS programs, which use the Case Management Information & Payrolling Systems (CMIPS II) and Electronic Timesheet System. EVV Phase II will implement the state's EVV solution through its contract with Sandata for non-CMIPS affiliated, agency-model PCS and self-directed and agency model HHCS.

Assistive Services

For individuals with disabilities, DHCS will provide free assistive devices, including language and sign-language interpretation, real-time captioning, note takers, reading or writing assistance, and conversion of training or meeting materials into braille, large print, audio, or electronic format.
