## Revised E-List Layout Changes

This is an advisory notification to Molina Healthcare of California (MHC) network IPAs, Medical Groups, Management Service Organizations, and delegated vendors who receive the E-List.

**WHAT YOU NEED TO DO:**

As noted in Just the Fax Assembly Bill 1184 Medical Information – Confidentiality, your organization will need to ingest the following additional one (1) element on the E-List to ensure compliance with regulatory requirements. This is a revised version of the one that was socialized on October 4, 2023.

The E-List will be sent out on a weekly basis since the statute requires "a confidential communications request shall be implemented by the health care service plan within 7 calendar days of receipt of an electronic transmission."
