Prior Authorization Update for 2024 Medi-Cal Managed Care Plan Transition

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to the Medi-Cal line of business.

What you need to know:

On October 20, 2023, MHC sent a communication informing providers that Prior Authorization (PA) will be removed from a select number of CPT codes for 90 days.

When this is happening:

Effective January 1, 2024, through March 31, 2024, PA is waived for select codes.

This communication serves as a notice to providers that the PA waiver will no longer apply after March 31, 2024.
