E-List Changes

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to all lines of business, IPAs, Medical Groups, Management Service Organizations, and delegated vendors who receive the E-List.

What you need to know:

When is this happening:

The first distribution of the revised E-List will be on 04/10/2024.

Provider Action

1. Please ingest the E-List:
 - ✓ In its revised form i.e., including the NDD flag
 - ✓ Its established cadence i.e., a semi-monthly distribution, and
 - ✓ With effect from the 04/10/2024 distribution.
2. Further, when MHC receives a compliant Confidential Communications Request, we will distribute an ad hoc communication with the pertinent information. The mode of communication is still being determined. We will follow up with further updates.

Timely ingestion of the ad hoc communication changes is necessary to meet the following CA Assembly Bill – 1184 requirement “a confidential communications request shall be implemented by the health care service plan within 7 calendar days of receipt of an electronic transmission.”
