Pass-Through Payment Platform Change Notification

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to the Medi-Cal line of business. This notice is intended to update providers on the pass-through payment platform change.

What you need to know:

MHC has been leveraging JD Edwards EnterpriseOne (JDE) Accounts Payable (AP) system to process pass-through payments for directed payment programs such as Proposition 56. Effective Sep 2024, MHC will be issuing pass-through payments through ECHO Health Inc.

When this is happening:

Pass-through payments for existing and new directed payment programs will begin to be processed through ECHO Health Inc. effective **September 2024**.
