



## Assisted Living Facility Incentive

Molina Healthcare of Florida is excited to announce the implementation of our Incentive Program for our Long Term Care (LTC) Assisted Living Facilities. This new program begins on April 1, 2023.

The Assisted Living Facility Incentive Program provides quality bonus payments to reward care provided by our Assisted Living Facilities. The payments are based on meeting specific indicators for maintaining our members within your Assisted Living Facility and to support activities for our members in your Assisted Living Facility. Information on the details of the Assisting Living Facility Incentive Program, criteria for eligibility for the program, metrics, payments and other rewards is enclosed with this letter.

This is a voluntary program. Your facility is under no obligation to participate. If you do not wish to participate, please let us know by 4/17/2023 at [mflproviderservicesmanagement@molinahealthcare.com](mailto:mflproviderservicesmanagement@molinahealthcare.com) (Email subject: AFL VBP Program). You do not have to take any action if you would like to be part of the new program. As soon as your Assisted Living Facility meets the criteria noted, you will be eligible for the specific Incentive Programs. Participation in the program will not affect or change your current provider agreement with Molina.

Note that Molina Healthcare of Florida may elect to revise or stop the Assisted Living Facility Incentive Program at any time. You will be notified of any changes in advance.

## Molina Assisted Living Facility Incentive Program Summary

To be eligible for the Assisted Living Facility (ALF) Incentive Program, Molina has identified specific criteria for the ALF, which includes various services each ALF provides and number of members served. Based on the specific criteria outlined below, the programs in which the ALF can participate is noted. The description of the three (3) ALF Incentive Programs is provided below the table.

## Program Descriptions

### Community Permanency – Transitions Program:

This program offers quality bonus payments which recognizes care provided to maintain the member safely in the ALF setting.

A payment of \$600 will be made to the ALF when a Molina LTC member transitions from a nursing home to the ALF and remains in that ALF for six (6) consecutive months. This payment can continue for each additional six (6) consecutive month period that the member continues to reside in the ALF.

#### Payments:

The payments are made twice a year. The calculation is completed one (1) month after the end of the six (6) month period with payment sent within 60 days of the end of the six (6) month period. [The ALF will receive a copy of their report used to calculate the Community Permanency – Transitions Program bonus payments.](#)

### Community Permanency – Stable Health Program:

This program also offers quality bonus payments which recognizes care provided by the ALF to maintain the member's health and avoiding acute care in a hospital setting.

A payment of \$300 will be made to the ALF for each month that a Molina LTC member continues to reside in the ALF and has not had an inpatient admission day (or observation stay) in an acute hospital facility within a three (3) consecutive month period. The member must be in the ALF for at least one full month before they qualify for the bonus. This payment can continue for each additional three (3) consecutive months that the member does not have an inpatient admission day (or observation stay) in an acute facility.

#### Payments:

The payments are made quarterly. The calculation is completed one (1) month after the end of the quarter with payment sent within 45 days of the end of the calendar quarter. [The ALF will receive a copy of their report used to calculate the Community Permanency –Stable Health Program bonus payments.](#)

### Healthy Living Program:

This incentive program provides a bonus payment to support activities that promote Brain Health. Through Molina's partnership with the Alzheimer's Association, our Cognitive Health Program includes interventions for our LTC members that follow the Alzheimer's Association "10 Ways to Love Your Brain". We recognize that our ALF providers can further support these interventions. This program provides funds to support activities for our LTC members residing within the ALF. Those activities include:



1. Art or other activity classes, which falls under the 10 Ways to Love Your Brain activity of Stump yourself – Engage in challenging activities and activate your mind, do something artistic or play games.
2. Reading materials, which falls under the 10 Ways to Love Your Brain activity - Hit the books – engage in some formal education activity.
3. Social activities, which falls under the 10 Ways to Love Your Brain activity - Buddy up – stay socially engaged.
4. Support sound nutrition by providing food from our community partners like Food Smart, which falls under the 10 Ways to Love Your Brain activity - Fuel up right – follow a healthy diet.

The ALF providers will receive \$25 per quarter per Molina member residing in the ALF for these activities. The ALF will provide information to Molina on the activities provided with this payment.

**Payments:**

The **Healthy Living Program** payments are made quarterly. The calculation is completed one (1) month after the end of the quarter with payment sent within 45 days of the end of the calendar quarter.
