# **Immunization Billing Guidance**

Immunizations are a major part of practice overhead, and they greatly impact the health and well-being of patients and families. Your practice needs to bill for immunization administration correctly to get paid.

You may also bill one or more immunization administration codes when you bill an immunization procedure, such as a Measles, mumps, and rubella virus vaccine (MMR).

For every immunization injection a patient receives, with counseling by a qualified medical professional, you may bill the correct immunization procedure and administration codes.

You may bill the vaccine procedure and additional immunization administration codes when a single shot immunizes against multiple diseases, such as MMR, DTaP, or any other combination of vaccines.

If you provide and document immunization counseling and provide an opportunity for questions, you may bill the administration codes that include counseling.

If you provide vaccines and do not provide counseling to your patients about the immunizations, then you may bill the administration codes that exclude counseling.

The primary Current Procedural Terminology (CPT) codes for vaccines change over time. Please review your immunization CPT codes periodically and reference the American Academy of Pediatrics (AAP) Vaccine Coding Table).

### **Examples of Immunization Billing**

Immunization billing requires that you understand the immunization and its antigens. Refer to the AAP Vaccine Coding Table examples below.

Suppose multiple vaccines are administered to a patient, such as a Hepatitis B or MMR, and counseling is provided. In that case, you may bill the first vaccine procedure code, the next vaccine procedure code, the immunization administration code, and the additional administration code for the additional antigens.
