## **Provider Services Team**

Molina's Provider Services Department supports multiple functions with network development. Our Provider Services staff liaises between the health plan and the provider community. This includes provider network evaluation and compliance with regulatory network capacity standards. Our staff is responsible for provider training, education, and coaching. The provider services representative territory assignment is based on providers servicing zip codes and/or a centralized billing office. - Provide onsite visits and assessments.
- Provide support on Medicaid policies and procedures.

## **Meet the Team**

Provider Services Representatives are assigned to our in-network providers by servicing zip code. Providers with multiple locations (large health systems and large groups) are assigned a PSR based on the zip code of their centralized billing location.
