As such, the Molina Healthcare of Nevada leadership team is excited to announce a program in place for the duration of 2023 intended to provide incremental compensation to our providers in delivering these essential visits – **Molina Healthcare of Nevada Commitment to Wellness Push 2023**.

Details of this exciting program include:

- Molina Healthcare of Nevada will process applicable claims to add an incremental \$15 wellness payment to providers for claims described below, in addition to normal claims processing guidelines.
- Applicable claims will be reprocessed in 2024 to include this incremental payment by April 30th, 2024.

The following table applies to: The first claim for a Molina Healthcare of Nevada Medicaid member for one of the qualifying codes below submitted and accepted as a clean claim prior to 1/15/2024 for a date of service 8/1/2023 through 12/31/2023.

Providers are eligible for one claim per member.

Excludes: Members who received qualifying services with a date of service 1/1/2023 through 7/31/2023.

Only one \$15 incremental payment per eligible Molina member.
